

ICD-10 Behavioral Health Authorization Request Forms Now Available

New Behavioral Health Service Authorization Request forms with fields for ICD-10 Diagnosis Codes are now available on the forms page at <http://manuals.medicaidalaska.com/docs/forms.htm>. These new forms will be in effect on October 1, 2015 and must be used with treatment plans that have a begin date on or after October 1, 2015. Current Service Authorizations that are approved with through dates on and after October 1, 2015 will continue to be in effect. For retroactive Service Authorization requests on and after October 1, 2015, Behavioral health providers must use the correct version of the Service Authorization form based on the treatment plan begin date.
