The Behavioral Health Center with the Emergency Services/Disaster Response responsibility for that service area is identified as a Community Behavioral Health Center.

The Community Behavioral Health Center is responsible to provide 24/7 psychiatric emergency services and participate in or initiate the development of a behavioral health component to the disaster response plan in their community service and planning area.
