

Tobacco Use and Exposure – Juneau Borough



Note: Prenatal smoking, PRAMS 2000-2006 data, for region including Haines and Juneau Boroughs and Skagway-Hoonah-Angoon Census Area. Other indicators, BRFSS 2004-2007 data. 95% confidence interval half-widths (margins of error) are presented in parentheses.

Community Indicators for Juneau Borough

- 89% of adults have a household ban on smoking (± 2%)
- 85% of adults agree that smoking should not be allowed in public indoor areas (± 3%)
- 76% of adults agree that smoking should not be allowed in restaurants (± 3%)
- 89% of those who work mostly indoors are protected by smokefree workplace policies (± 3%)
- 51% of smokers tried to quit in the past year (± 7%)
- 51% of current and former smokers started smoking regularly before age 18 (± 6%)


2007 population: 30,305

Approximately:


- 4,160 adults smoke
- 810 adults use smokeless tobacco
- 2,320 adults are exposed to secondhand smoke in their homes
- 550 youth are exposed to secondhand smoke in their homes
- 35 infants are exposed prenatally* to tobacco smoke each year
- 100 cancers diagnosed in the past five years are smoking-related
- 115 adults have died in the past five years from smoking-related causes

Statewide Summary on Youth and Tobacco

- Cigarette smoking among Alaska high school students has decreased from 37% in 1995 to 18% in 2007
- Cigarette smoking among Alaska Native high school students has decreased from 62% in 1995 to 32% in 2007
- In 2007, 69% of Alaska youth smokers got their cigarettes primarily from other people around them
- 9% of retailers sold tobacco products to minors in 2007

Local Policies and Activities for Tobacco Prevention and Control – Juneau Borough

- The Alaska Tobacco Prevention and Control Program awards grants to local and regional organizations for local tobacco prevention and control. Contact the Program for an updated list of grantees.
- Local school districts may participate in the Youth Risk Behavior Survey, and organizations can work with them to obtain local information about youth tobacco use and exposure.
- Some boroughs and municipalities in Alaska have health and safety powers and can set local policy and taxes.
- The Borough of Juneau is a Unified Home Rule Municipality, with one unincorporated community in addition to the City of Juneau.
