Objective #1: Improve at least 5 policies for appropriate lifelong service access for all populations who experience intellectual and developmental disabilities and supports for their caregivers, specifically targeting Alaska's underserved population of individuals with neurodevelopmental disabilities.

Key Activities

1. Collect, review and share prior and current data on the goals, objectives, and activities of the Council.
2. Up to 3 Council members will serve on the Council's Fetal Alcohol Spectrum Disorders FASD (Fetal Alcohol Spectrum Disorders) Workgroup and meet at least 4 times per year.
3. At least 3 Council members will serve on the Council's Autism Ad Hoc Committee and meet at least 3 times a year.
4. Research barriers that prevent working caregivers from maintaining other employment.
5. Partner to increase greater use of assistive technology, particularly to rural and remote

Alaska.

6. Conduct statutorily mandated responsibilities as a beneficiary board to the Alaska Mental Health Trust Authority (The Trust).
7. Collaborate with the Alaska Mobility Coalition to enhance community transportation options statewide.

Expected Outputs

1. At least 1 policy annually will be improved related to appropriate lifelong service access for all populations who experience intellectual and developmental disabilities.
2. The Autism Ad Hoc Committee will meet at least 3 times a year, and will review and update the progress on the Autism Five Year Phase II plan annually.
3. The FASD Workgroup will meet at least quarterly to coordinate FASD advocacy.
4. Barriers that prevent caregivers from adequately caring for family members with a disability while maintaining other employment, will be understood.
5. At least 3 meetings or events a year completed with the Alaska Mobility Coalition.
6. At least 3 Trust meetings completed as a beneficiary board to the Alaska Mental Health Trust Authority.

Expected Objective Outcomes

1. Reviewing data from past Council initiatives will allow the Council to identify successful programs and initiatives.
2. Collaborating on activities influencing statewide tele-practice policies will increase the frequency, quality and scope of services to families statewide.
3. Researching the challenges of caregivers will identify barriers that the Council can address in future initiatives.
4. Improving 1 policy annually will ensure that more individuals, and their caregivers, have access to lifelong services and supports.
5. The development of a comprehensive work plan for system changes that improve the services, supports and outcomes of Alaskans with FASD.
6. The collaborative Autism Five Year Plan Phase II that is being coordinated by the Council, will be annually reviewed and the plan implemented.

Data Evaluation And Measurement

1. Council minutes and transcripts will be reviewed to identify successes.
2. Sign-in sheets, meeting minutes and tally counters will be reviewed regarding numbers engaged in events and meetings that are part of statewide collaborations on tele-practice initiatives.

- 3. Research, reports and websites shared on the barriers of caregivers will be documented by meeting minutes and website, GovDelivery and social media data.
- 4. Sign-in sheets, meeting minutes and tally counters will be reviewed regarding numbers engaged in events and meetings to document the policy improvement activities.
- 5. Sign-in sheets, meeting minutes, tally counters will be reviewed regarding numbers engaged in FASD Wrokgroup and other FASD events and meetings to document collaborative activities meetings to document the policy improvement activities.
- 6. Meeting minutes and sign-in sheets will document participation in an annual meeting to review the Autism Five Year Plan.

- 1. Monitor, review, comment, and raise awareness of statutory, regulatory and policy changes around the delivery of person-centered IDD services in Alaska.
- 2. Monitor, review, comment, and raise awareness of the state's transition to person-centered conflict-free case management and transition to fully HCBS integrated settings

Expected Outputs

1. At least 3 public comments made annually relating to statutory, regulatory, or policy changes relating to person centered planning.
2. Post at least 3 Facebook posts, GovDelivery listserv emails, and website headline bulletins related to regulation, policy, or statutory changes conflict free case management and/or HCBS annually.

Expected Objective Outcomes

1. More Alaskans with disabilities and their families will be reached regarding public comment opportunities related to changes to HCBS.
2. More agencies and users will have information to incorporate enhanced person-centered practices in their delivery of home and community-based services.
3. Opportunities for stakeholder input on SDS regulations and policies regarding person-centered practices in the delivery of home and community-based services.

1. Data will be collected on Facebook post reach, likes, and shares.
2. Data will be collected on GovDelivery listserv emails regarding overall reach and links opened.

1. Review and share information to the general public on issues that affect the lives of individuals who experience IDD's.
2. Increase public communication on Council activities at least 10 times per year through the use of social media (Facebook, twitter), website, radio, television and other means.
3. Participate in community activities that increase our involvement and interaction with the public.

Expected Outputs

1. The Council will have 50 public service announcements a year through radio, social media, and newsletters on the issues and topics that impact the lives of individuals with I/DD's.
2. Increased readership of social media and websites by 200 viewers.
3. Increased community involvement by having at least 1 new council member or staff on a community group.

Expected Objective Outcomes

1. By increased outreach, the Council will be able to provide the public with more disability related best practice information.
2. Increased engagement of the Council members, stakeholders and the public in Council and other advisory, assistance or advocacy boards, commissions or initiatives or events.
3. Increased public response on social media to guide the Council's future activities and improve overall community expectations of Alaskans with disabilities.

Objective #4: Expand opportunities for individuals with intellectual/developmental disabilities and their families to become engaged in self-advocacy and self-advocacy leadership, strengthening the state's self-advocacy organization, participating in at least 2 annual legislative advocacy efforts that improve policies and programs for persons with disabilities to include statewide coalition participation.

Key Activities

1. Identify and recruit advocates and self-advocates for vacant Council seats.
2. Provide leadership training and advocacy opportunities to at least 5 Council members, self-advocates, and family members annually.
3. Continue to support statewide self-advocacy.
4. Increase communication, collaboration, and participation in the Key Campaign, an annual advocacy effort with the legislature led by the Key Coalition and fund travel for 5 individuals with developmental disabilities and/or family members to participate in the Key Campaign once a year by 2021.
5. Develop a mentorship program for new Council and committee members that will pair self-advocates with both staff and/or mentor council members.

Expected Outputs

1. Annually, 5 individuals with developmental disabilities and/or family members to participate in the Key Campaign.
2. At least 2 general membership meetings supported for the statewide self-advocacy organization.
3. At least 2 new Council or committee members will be paired with self-advocates through a developed Council mentorship program.
4. Annually, 1 Council meeting will focus on legislative advocacy/self-advocacy.

Expected Objective Outcomes

1. Legislators will have more information on policies and bills that impact people with I/DDs, and hear from advocates/self-advocates themselves to personalize key disability-related issues.
2. Council members and stakeholders will have increased advocacy opportunities.
3. Council members and stakeholders will have increased opportunities for leadership training.
4. Increased self-advocacy state-wide efforts, such as Peer Power Alaska.
5. Mentorship will facilitate new Council members understanding of their role and responsibilities and encourage active involvement by all members.

Data Evaluation And Measurement

1. Tallies of emails, meeting minutes, face-to-face meetings and other information sharing activities will be totaled.
2. Sign-in sheets, meeting minutes and tally counters will be reviewed regarding numbers engaged in events and meetings that increase advocacy opportunities.

Provide justification for selecting Demonstration of New Approaches to Services and Supports

Initial project start date: 10/01/2012 Alaska Integrated Employment Initiative (AIEI) is a transition systems change grant, a Project of National Significance, through the Administration on Intellectual and Developmental Disabilities, Administration for Children and Families, US Department of Health & Human Services. AIEI is administered by the Governor's Council on Disabilities and Special Education and is part of the federal Partnerships in Employment Project. The 5-year grant is set to conclude September 30, 2017; however, a 6th year no cost extension will most likely be requested which would place the end date at September 30, 2018 if approved. AIEI demonstration work includes: 4 Project SEARCH demonstration sites with expansion efforts noted in this plan, and a Discovery Pilot Project enhancing transition classes by incorporating discovery techniques and activities into existing transition classrooms subsequent to teachers going through a distance delivered discovery class (collaboration with Alaska's UCEDD).

Objective #1: Provide support for the implementation of Alaska state laws increasing the employment of individuals with disabilities which lead to 2 new or improved policies, procedures, or regulations per year.

Key Activities

1. Monitor legislation relating to employment for individuals with disabilities and provide support for advocacy and research, as needed.
2. Provide support for the implementation of the Alaska Employment First Act through at least 2 meetings or events annually, with at least one improved policy, procedure, or regulation per year.
3. Provide support for the implementation of the Alaska Achieving a Better Life Experience (ABLE) Act as it relates to empowering employment for individuals with disabilities through at least 2 meetings or events annually, with at least one improved policy, procedure, or regulation per year.

Expected Outputs

- 1.2 meetings or events held related to Employment First implementation.
- 2.1 policy, procedure, or regulation will be improved relating to Employment First Act implementation.
- 3.2 meetings or events held related to Alaska ABLE Act implementation.

Expected Objective Outcomes

1. More policies and procedures will specifically denote the competitive and integrated employment concepts of Alaska's Employment First Law, resulting in state agency practices that focus service provision towards employment, especially employment which includes at least minimum wage and more meaningful community jobs for Alaskans with disabilities.
2. More Alaskans with significant disabilities will be aware of the opportunity to work, saving their earned income, without risking the loss of their needed public benefits by utilizing an ABLE account option.

- 1.Data collection via reporting required by the Employment First Law from the Departments of Health and Social Services, Labor and Workforce Development, and Education and Early Development annually to the Trust.
- 2.Data collection from the Department of Revenue regarding the number of Alaska ABLE accounts.
- 3.Sign-in sheets, and tally counters will be reviewed regarding numbers engaged in events and meetings.
- 4.Surveys to stakeholders for the PPR to measure project activity effectiveness.

Objective #2: Increase career pathways for youth (ages 16-26) that will contribute to a 10% increase in the employment rate for youth with disabilities by 2021 in integrated and competitive employment in partnership with Alaska's P&A, UCEDD, and State DD agency as well as state self-advocacy organization.

Key Activities

- 1.Complete at least 2 outreach meetings or events towards the expansion of Alaska Project SEARCH sites, expanded by 2 sites by 2021.
- 2.

- Collaborate with the Alaska Job Center Network on the Disability Employment Initiative, Division of Vocational Rehabilitation on Work Incentives and Opportunities Act implementation of PETS, and the Trust Beneficiary Employment and Engagement Initiative regarding youth transition programs in the state; collaborating on at least 3 activities, trainings, or events per year in partnership with the P&A, UCEDD, and state self-advocacy organization.
 - 3. Hold at least one training per year to increase the use of discovery techniques and activities in schools to enhance post-secondary transition in partnership with Alaska's UCEDD.
 - 4. Partner with Alaska's UCEDD, to expand post-secondary education options, participating in at least one activity, event, training, or meeting per year.

 - 8. Partner with the Alaska's P&A to obtain, and share information about the use of subminimum wage in Alaska, reaching out to at least one 14(c) certificate holding entity annually with resources for transition to minimum wage and above.
 - 9. Collaborate with the State DD agency on enhancement of supported employment HCBS services, holding at least 1 meeting on this annually.

Expected Objective Outcomes

- 1. With increased state agency collaboration and DD network planned collaboration on post-secondary transition initiatives, more Alaskan youth and young adults with disabilities will be employed in competitive and integrated employment before they reach the age of 26. o DVR

- o youth caseload (ages 16-26) increasing from 30% to 40% and with DVR youth with I/DD caseload increasing from 15% to 25% by 2021.
 - o SDS I/DD waiver youth and young adult (ages 16-26) utilization of supported employment services increasing from 166 individuals to 182 individuals by 2021.
 - o Indicator 14 (Measure B) data denoting recent Alaskan students with disabilities a year after exiting school services increasing in rates of being engaged in higher education or competitive employment, from 43.4% to 53.4% by 2021.
2. An enhanced transition system, assisting not only students and family members, but teachers as well, to understand best practices around post-secondary transition in addition to available resources, including long term services and supports.
 3. Less Alaskans will be paid subminimum wage under 14(c), especially youth and young adults with disabilities.

Data Evaluation And Measurement

1. Sign-in sheets, and tally counters will be reviewed regarding numbers engaged in events, trainings, and meetings.
2. Data points denoted above in expected outcomes will be collected from Alaska's Departments of Labor, Health and Social Services, and Education and Early Development for youth and young adults with disabilities (ages 16-26).
3. Surveys to stakeholders for the PPR to measure effectiveness of transition efforts, with additional survey data collected from Alaska's UCEDD related to effectiveness of the trainings held.
4. Data on 14(c) via FOIA request and federal CRP list will be collected and reviewed in partnership with Alaska's P&A.

Objective #3: Work with partners to develop and implement a plan to increase the number of individuals with intellectual and developmental disabilities who are employed by 10% by 2021 in integrated and competitive employment.

Key Activities

1. Advocate for changes in the State's IDD HCBS waiver on supported employment services, providing at least one recommendation per year.
2. Hold at least 1 meeting annually regarding funding opportunities to increase the number of Community Work Incentives Coordinators (CWICs).
3. Increase asset building opportunities for Alaskans with disabilities, participating in at least one event per year.
4. Work with Alaska's UCEDD and the Trust, to increase provider capacity for employment services and supports, holding at least 2 trainings per year.
5. Hold one meeting per year for providers, employers, and agencies interested in becoming Ticket to Work Employment Networks.
6. Disseminate information on employment through job fairs, conferences, and other events, participating in at least 3 such events annually.
7. Increase awareness and utilization of the Alaska Disability Benefits 101 online tool, participating in at least 3 events or activities per year to disseminate information or provide user training.
8. Provide support to the Business Employment Services Team collaborative (BEST), participating in at least 3 employer engagement events, meetings, or trainings per year.
9. Advocate annually for a percentage hiring benchmark for State contracts on hiring people with disabilities, achieved by 2021.
10. Increase opportunities for individuals with IDD to become self-employed using the Micro-enterprise program, disseminating program information through at least two events per year, with at least one informational training per year.
11. Collaborate with the Alaska Association of People Supporting EmploymentFirst (APSE) Chapter, with Council staff supporting at least 5 meetings and 1 CESP exam annually.

Expected Outputs

- 1.1 recommendation on HCBS IDD waiver supported employment service enhancement

completed.

2.1 meeting held regarding funding for new CWICs to be certified in Alaska.

3.1 asset building event supported.

4.2 employment services trainings held.

Expected Objective Outcomes

1. More Alaskans would be employed in competitive and integrated employment, with the target being Alaska's employment rate for individuals with disabilities increasing from 47.2% to 57.2%; and Alaska's employment rate for individuals with a cognitive disability increasing from 34.5% to 44.5% by 2021.

6. Capacity would be built with respect to training providers in best practices and promising practices around employment with providers overall demonstrating a high competency level in employment support services.

2. More Alaskans service providers will assist their consumers with preparing for a disaster by helping their consumers complete an emergency plan.
