**Moving?** Whether you receive your payment electronically or by check, foster care licensing regulations and adoption or guardianship subsidy agreements require immediate notification if you have moved or plan to move. Moving without appropriate notification may affect your monthly foster care reimbursements or Medicaid eligibility for your children. Please notify your licensing worker or the Adoptions Unit of any plans for re-locating.

**Payment delays?** Please contact your caseworker to ensure payment has been validated for the previous month.

Once a paper check is issued, a two-week delivery allowance is required before payment can be stopped and re-issued. Payments issued electronically will post to your bank account two (2) business days from the date of release.

NOTE: State and federal holidays may delay payment release dates by two (2) business days.
