Notes

- AN/AI Children in Custody represents all children who came into care or were in care during the calendar year
- *Maltreatment is the count of children with substantiated maltreatment in investigations completed during the reporting period. Numbers/rates may be impacted by data latency.
- Repeat Maltreatment consists of repeat victims with a previous substantiated allegation within the prior 12 months.
- Placement data is point in time on December 31.
- ICWA Foster Home data was extracted on 1/2/20.
- Tribal Interventions represent the number of children who had an intervention during the reporting year. If an intervention occurred after the reporting period it is not included in this number. Children in non-intervening tribes includes all AN/AI children who do not have a tribal affiliation listed in ORCA.
- Re-Entry into Care: Children removed from home during the reporting period who have a discharge within the 12 months prior to their most recent reporting period removal date
- Reunification totals are based on number of children discharged with an end reason of reunification and children on a trial home visit over 180 days or expired.
