### Introduction

This publication provides detailed information on the operating grants awarded by the Department of Family and Community Services (DFCS) in Fiscal Year 2024. Through these grant programs, the department partners with approximately 34 agencies across the state to provide a variety of services such as placement care shelters, adoption and guardianship services, contact and protection settings providing a stable and secured environment for vulnerable children and families. In Fiscal Year 2024 the department awarded over \$8.4 million through grants and managed over 48 operating grants. Details provided for each grant program include a brief narrative, Results Based Budgeting Framework, grantee name, services area, fund source and award amount. Also included in this publication, is a DFCS Regions map providing a graphic description of the regions adopted by the department, which helps assess distribution of services and resources across the state. Lastly, an Election District report is included to delineate grant services provided in each election district. Grant programs are managed collaboratively with each of the department's divisions and Management Services, Grants Section. We welcome your suggestions and any recommendations you may have on how best we can address and respond to the needs of Alaskans and improve our services through our grant programs.

## Juvenile Justice



### Federal Formula Non-Secure Attendant Care Shelter

### **Granting Authority:**

- 7AAC 78 Grant Programs
- AS 47.05.010(7), AS 47.14.010(6)

### **Description of Services:**

Non-secure attendant care shelters provide short-term staff-secure placement for referred youth and youth placed into protective custody until they can be safely released to a parent/guardian or transferred to a residential or juvenile detention facility. Referrals are made by the Division of Juvenile Justice's (DJJ) juvenile probation officers, by local judicial and law enforcement officers, as well as by schools. Shelter attendants provide one-to-one, same gender supervision to referred youth in staff-secure settings. Shelter service is available 24 hours per day and is provided within 45 minutes of notification of need. Shelter placements may not exceed 16 hours unless an extension is authorized. Agencies will use funds under the Grant Agreement to pay for limited administrative and operating costs associated with program readiness. As a condition of receiving an award, the provider will also enter into a Provider Agreement. The State of Alaska will utilize Provider Agreements to pay for the cost of services provided to the youth.

### Assessment of Need:

The Federal Formula Grant Program makes funds available to states to improve juvenile justice systems and implement delinquency prevention and intervention strategies as mandated in the Juvenile Justice and Delinquency Prevention Act. In FY89, DJJ began using a portion of its Formula grant to support a statewide network of non-secure shelters. A strong and viable statewide system of non-secure shelters has been instrumental in reducing violations of the first three core mandates by providing temporary placement for youth placed in protective custody.

### Formula Title II Grant Program

### **Granting Authority:**

- 7AAC 78 Grant Programs
- AS 47.14.010(6) General Powers of Department over Juvenile Institutions; AS 47.05.010(7) Duties of Department

### **Description of Services:**

Program services consist of the solicitation and administration of pass through sub-awards. Administration includes technical assistance to communities in post-award project development, grant management, and reporting. Direct services are sub-awarded to Alaska Native tribal partners in rural communities. Through positive, culturally based youth development projects, at-risk youth gain self-worth, a sense of belonging, and community and cultural membership.

### Assessment of Need:

Services are necessary to the State's adherence to core mandates of the Office of Juvenile Justice and Delinquency Prevention (OJJDP). Alaska Native youth are disproportionately referred to the Division of Juvenile Justice: 38% of all referrals, though only 17.2% of the statewide population. With prevention services, Alaska Native youth referral rates are reduced, as is the degree of disproportionate minority contact. The program further meets the division's intention to work effectively with tribal partners in support of cultural and community based delinquency prevention projects supporting at risk youth.

The target population for end services is Alaska Native youth in rural communities.

### Youth Courts/Community Panels

### **Granting Authority:**

- 7AAC 78 Grant Programs
- AS 47.14.010(6) and (7); AS 04.16.050(b)(1) and AS 47.12.400

### **Description of Services:**

Program services include case screening, adjudication, disposition, and case management for youth who are referred for non-violent first or second time misdemeanor offenses, and/or status offenses. Cases are tried with representation and adjudication by the defendant's peers. Referral sources are DJJ field offices, local school districts, and District Courts.

#### Assessment of Need:

The program's early intervention and diversion services supplement and broaden the range of accountability-based restorative justice services for youth. Benefiting victims and communities, program services allow for the swift application of graduated responses, proven to be effective in preventing, controlling, and reducing further delinquent behaviors.

**Service Delivery Area:** Statewide. Resources will be allocated based on demonstrated need for services as supported by available data.

## Office of Children's Services



### Adoption and Guardianship Home Studies for Resource Families

### Granting Authority:

- 7AAC 78 Grant Programs
- Federal Adoptions and Safe Families Act (ASFA, 1997), AS 25.23.100 AS 25.23.150 and AS 47.10.080 10.088

### **Description of Services:**

Services are assessment of individuals or families identified as permanent homes for children in the custody of the Office of Children's Services (OCS). Assessments, or home studies, consist of background checks, home visits, interviews with each family member, interviews with collateral sources and references. The assessment also helps the family assess its own readiness and motivations for adoption/guardianship, while providing education and preparation. All assessments are reviewed for approval by OCS regional permanency staff.

### Assessment of Need:

OCS is required to complete a home study when a home is identified as a potential permanent placement and prior to the finalization of an adoption or guardianship of a child in care. At the end of Fiscal Year 2020, there were 3176 children in out of home placement. OCS completes an average of 400 adoptions and guardianships per year.

### Children's Advocacy Centers

Granting Authority: 7AAC 78 - Grant Programs

### **Description of Services:**

Children's Advocacy Centers (CACs) help to identify maltreated children and protect them from further harm. CAC's provide referrals to treatment and follow up, hold offenders accountable, and provide community outreach and education regarding child abuse. A comprehensive, child-centered response in suspected cases of child abuse includes the coordinated efforts of a multidisciplinary team (MDT) including law enforcement, district attorneys and the assistant attorney general's office, child protection, victim advocates, as well as mental and medical health professionals.

#### Assessment of Need:

Centers accept referrals of suspected sexual abuse and other severe abuse of children up to age 18. Most also accept referrals of developmentally disabled young adults and those with cognitive impairments such as Fetal Alcohol Spectrum Disorder.

Referrals continue to increase due to the State's broad support for effective CACs and increased community awareness regarding child abuse and child sexual abuse. Current centers are stable but not self-sustaining. This will also offer some cost savings to CACs currently serving children from outside the center's locale.

### Circles of Support Family Preservation Services

Granting Authority: 7AAC 78 - Grant Programs

### **Description of Services:**

Under this program, grantees will provide family preservation services to families who have experienced contact with the Office of Children's Services and are at risk of future child maltreatment and/or child removal to an out of home placement. These clients, with children currently in their care, have had an allegation or substantiated report of child maltreatment or a finding of Child in Need of Aid has been determined in judicial court. They may be currently actively working with OCS.

Grantees will be responsible for providing in-home family support, coaching and education services, coordination of identified support services which may include substance abuse assessment, urinalysis testing, support for the parents to eliminate any health or safety hazards in the child's physical surroundings, assistance with seeking a protective order if domestic violence is a factor, mental health evaluation or stabilization as well as close supervision and frequent monitoring.

### Assessment of Need:

Federal requirements outline that the caseworkers need to visit homes on a frequent basis to reassess the safety of the child at every contact, work with providers and ensure the children's needs are also being met while the parent is addressing their identified areas of need. OCS anticipates 10 - 50 families will be served under this program at any given time.

Service Delivery Area: Services are sought in the following OCS regions: Anchorage, Northern Region, and Southcentral Region.

### **Community Family Education**

Granting Authority: 7AAC 78 - Grant Programs

### **Description of Services:**

Community Family Education services are community-based parenting education services aimed at strengthening the parenting skillset of the target community's parenting population in order to promote the safety and wellbeing of children and families. The target populations are young parents, new parents, families with children age birth to 17 years, and families who have a member who experiences a disability.

### Assessment of Need:

OCS statistics reflect a high number of substantiated allegations of abuse or neglect, illustrating families across the state of Alaska struggle to appropriately parent their children. A needs assessment identified the need for local resources for parenting education and support.

**Service Delivery Area:** Statewide. Grantee must have a physical presence in the community in which they are applying to provide services.

### **Emergency Shelter Services for Youth**

### Granting Authority:

- 7AAC 78 Grant Programs
- AS 47.40.011 Purchase of Services for Minors, AS 47.14.100 Powers and Duties of Department Over Care of Child, AS 47.10.011 Children in Need of Aid, 7 AAC 50.100 Community Care Licensing, and 7 AAC 50.615 Emergency Shelter Care for Runaway Children

### Description of Services:

Emergency Shelter Services are needed for homeless runaways and at-risk youth, ages 13–20. Services provided will consist of basic needs and will offer help with education, employment, health services, counseling and family mediation. Each youth in the program will be provided with a case manager.

### Assessment of Need:

Under AS 47.14.100 Powers and Duties of Department Over Care of Child, the Department must arrange for the care of every child committed to its custody by placing the child in a foster home or in the care of an agency or institution providing care for children inside or outside the state. The same statute allows the Department to pay necessary costs to ensure adequate care. Approval of this request will ensure that critical Emergency Shelter Services will continue to be available to the Department.

### Description of Services:

These services are designed to provide ongoing family contact, limited child transportation services and documentation of services for Office of Children's Services (OCS) involved families where the children have been removed from the home. Services can be provided in agency, home or community settings. The program goals are to facilitate ongoing relationships with siblings and parents, and to reunify the child with their biological parent(s).

### Assessment of Need:

Federal law requires that children in out of home care maintain contact with siblings and parents. OCS statistics currently show 2,289 children in out of home care, of whom 1,402 are located in our major urban areas.

**Service Delivery Area:** Funds will be allocated in the Municipality of Anchorage, the Matanuska-Susitna Borough, Kenai Peninsula Borough, and the Fairbanks North Star Borough.

### Post Adoption and Guardianship Support

Granting Authority: 7AAC 78 - Grant Programs

### **Description of Services:**

This program will provide post-adoptive and guardianship support services to include general resource and referral information for adoptive and guardianship families, adoptive/guardianship family support groups, connection to advocacy networks, mini-grants for therapeutic needs, and an optional innovative service to enhance post-adoption/guardianship services in Alaska. While services are open to all adoptive or guardianship resource families in Alaska, most served will be families who have adopted or become guardians of a child from the Office of Children's Services (OCS) foster care system. This grant program was formerly known as Services for Adoption Support.

### Assessment of Need:

The program's target populations are post-adoptive/guardianship resource families. Families who have adopted or entered a guardianship with children from OCS have special parenting needs due to their children's history of experienced trauma. Children adopted from foster care have history of experienced physical maltreatment and/or neglect and often struggle with feelings of abandonment and grief over the loss of their birth families. Many children who have been adopted have a significant level of special needs, for which adoptive and guardianship families need support. Families often need services which are sensitive to the issues adoption and guardianship families face. Families who have adopted children from other states as well as privately through domestic or international adoption agencies, may also face special challenges. The program meets Department needs for post-adoption support.

Based on data in the Online Resources for Children of Alaska (ORCA) database, at the end of State Fiscal Year 2020, there were 3937 children in Alaska's subsidized adoption and guardianship program. In FY20, OCS finalized a total of 437 adoptions and legal guardianships for children in foster care.

### Resource Family Training

### Granting Authority:

### Description of Services:

The program provides a point of initial inquiry and contact for prospective resource families in Alaska. Services consist of planning, developing and implementing on-site and distance trainings for Office of Children's Services (OCS) resource families. Trainings utilize self-study packets, video and audio tools, on-line resources and teleconferencing. Culturally appropriate training and support of rural resource families via Indian Child Welfare Act Workers or other community members identified by Tribes and OCS staff is strongly emphasized. Intensive preparation services consisting of one-on-one education, family preparation classes, and matching support for families committed to special needs adoption will be provided in the Southcentral and Anchorage regions only. The program provides, to foster parents in every Resource Family home, accessibility to training to meet minimum annual requirements established by 7 AAC 50.250(g). Program services also include administration of the Resource Family Advisory Board.

### Assessment of Need:

The program's target populations are Alaska's current and potential Resource Families providing foster and kinship care and/or pursuing adoption of children in out-of-home placement under OCS custody. The program meets the Office of Children's Services need for recruitment, training, individualized training plans and support of a continuous pool of safe, stable, trained and culturally appropriate families with which to place children in State of Alaska custody.

At the end of calendar year 2022, there were 2,787 children in out-of-home placement. Additionally, at the end of 2022 there were 1,784 OCS licensed foster homes in Alaska, 1,259 of which were non-child-specific. Due to the continued increase in number of children in need of out-of-home placement, the Department anticipates a higher demand for new Resource Families as well as for training and support for existing Resource Families.


