Dear Tribal Health Leaders

On behalf of the Department of Health and Social Services (the department) and in keeping with the responsibility to conduct tribal consultation, I am writing to inform you of a proposed Medicaid state plan amendment (SPA). The state offers this opportunity for consultation on the state plan concurrently with the opportunity for public comment on related proposed regulations.

## Purpose and content of the proposed amendment:

The department intends to submit an amendment streamlining language surrounding the reimbursement of services rendered using telemedicine applications. The proposed SPA will <u>remove existing language</u> listing specific services eligible for reimbursement when rendered via a telemedicine application (below).

Reimbursement is made for a telemedicine application if the services is:

- 1. An initial visit;
- 2. A follow-up visit;
- 3. A consultation made to confirm a diagnosis;
- 4. A diagnosis, therapeutic referrals/orders, or interpretive service;
- 5. A psychiatric or substance abuse assessment; or
- 6. Psychotherapy or pharmacological management services on an individual recipient basis.

The remaining language (below) clearly articulates the existing parameters of reimbursement for approved Medicaid services rendered using a telemedicine platform.

Payment for services delivered via telemedicine occurs [is made] according to the Medicaid payment methodology for the service and provider type.

Separate reimbursement is not available [made] for the use of technological equipment and systems associated with a telemedicine application to render the service.

#### Anticipated impact on Medicaid-eligible Alaska Native/American Indian beneficiaries:

The department does not believe the proposed revision will have a direct impact on tribal beneficiaries because reimbursement for services provided via a telemedicine platform continues.

## Anticipated impact on tribal health programs and the Indian Health Service (IHS):

The department does not believe that the removal of this language will have a direct impact on tribal health organizations or the IHS because reimbursement for services rendered via a telemedicine platform continues.
