RE: Alaska Medicaid Disaster Relief State Plan Amendment for Tests Ordered by Licensed Practitioners Tribal Consultation

Dear Ms. King,

The Alaska Native Health Board (ANHB)<sup>1</sup> thanks the Department of Health & Social Services (the Department) for the opportunity to submit written comments for Tribal Consultation on the Disaster Relief State Plan Amendment (DR-SPA or SPA) to allow for

- licensed practitioners operating within their scope of practice to order laboratory and radiology services;
- coverage of laboratory services provided outside an office, or similar facility other than a hospital outpatient department or clinic, when meeting the state's provider qualifications;
- reimbursement of laboratory services ordered by licensed practitioners operating within their scope of practice;
- licensed practitioners operating within their scope of practice to order home health services

We are supportive of these provisions for all non-physician practitioners, including Community Health Aide Practitioners (CHA/Ps), acting within their scope of practice to order laboratory and radiology services.

Noting that the DR-SPA will only be in effect through the end of the Public Health Emergency, we also support that these provisions be adopted through the regular Medicaid State Plan Amendment process. As you know, non-physician practitioners are an important link in the delivery of care in the Alaska Tribal Health System and in the larger Alaska health care system. Allowing licensed non-physician practitioners to order laboratory and radiological services, acting within their scope of practice, enhances the effective delivery of care at all times, and not only during a global pandemic.
